I **understand** that there are certain elements of risk involved with the rental and use of the above canoeing equipment including, but not limited to the following:

1. Exposure to variable extremes in weather that may cause injury due to heat or cold, and which may prevent or force route and itinerary changes.
2. Contact with and possible immersion in cold water for undetermined periods, leading to hypothermia and possible suffocation.
3. Exposure to capsizes, trees, rocks, bridge abutments, log jams, rope entanglement, current patterns and other possible sources of "in water" injury and entrapment.
4. Unfamiliar terrain and routes where canoeists could become separated from the party.
5. Travel in remote locations with poor communications and inability to get rescue or medical assistance easily and quickly.

I **accept** all of the risks and the possibility of death, personal injury, property damage and loss resulting from my involvement with the above rental.

I **release** Blue Canoe, Discover Banff Tours, The land owners and their employees and representatives from any and all liability for any personal injury, death, property damage or loss I may suffer as a result of the above rental.

I **agree** to pay Discover Banff Tours for any damage to, or loss of Blue Canoe equipment that may occur during my rental.

I **certify** that I am physically capable and fit to participate in this activity and have no medical conditions that may affect my safety during my participation.

I **confirm** that I am 18 years or older and if not will have a parent or guardian sign this waiver and release of claims. I also confirm that I have read over this agreement before signing, that I understand it, and that it will be binding, not only to me, but also to my heirs, next of kin, executors, administrators and assigns.
